American Pain Consortium Holdings Expands Into the Columbus, Ohio, Market With the Acquisition of Gemini Surgery Center

INDIANAPOLIS – American Pain Consortium Holdings (APCH) is pleased to announce its acquisition of Gemini Surgery Center (GSC), an ambulatory surgery center in Columbus, Ohio. APCH has also entered into an agreement to provide management services to Integrated Pain Solutions (IPS), a pain management physician practice affiliated with GSC. GSC and IPS were founded by Dr. Gladstone C. McDowell II, who has served as the Medical Director of IPS since April 2008.

Based in Indianapolis, APCH is the parent organization of Center for Pain Management, an Indiana pain treatment clinic with locations in Indianapolis, Greenwood, and Lafayette.
